- Hear about the most current Annual Purchase of Services (POS) Expenditures for Fiscal Year 2015-2016 (sometimes referred to as disparity data);
- Learn about the changes since last year;
- Find out about SG/PRC projects beginning in 2017 to promote equity and reduce disparities in accessing and utilizing regional center services, including purchased services;
- Share any challenges in working with SG/PRC and/or in obtaining services;
- Identify cultural barriers that might prevent members of your community from gaining access to services and discuss how to reduce or eliminate these barriers;
- Tell us the best ways to reach other members of your community; and
- Provide suggestions for additional ways to improve access and utilization of services for people with developmental disabilities.

**BACKGROUND:** As of June 27, 2012, the Lanterman Developmental Services Act was amended requiring the Department of Developmental Services (DDS) and Regional Centers to annually collaborate to compile data related to purchase of service (POS) authorization, utilization, and expenditure. There have been some amendments since 2012 and now these reports are organized by each regional center with respect to consumer (also known as client) age, race or ethnicity, primary language, disability, and residence type. The data, including the number and percent of consumers who are eligible for regional center services but are not receiving purchased services, must be posted by DDS and each Regional Center on their respective websites by December 31<sup>st</sup> of each year. In addition, regional centers are required to hold community meetings prior to March 31<sup>st</sup> to share this information with their community.
