LEGISLATIVE ISSUES AND OTHER INFORMATION:

Lucina Galarza, Interim Executive Director, reported on the following:

- Intake Data The committee reviewed the information. (See attached).
- Self Determination 95 individuals served by SG/PRC have been selected. As of now, 19 families are declining being a part of the program. Others are waiting to make a decision until after orientation. There was a sponsored "Train the Trainer" session by DDS on February 25, 2019. Staff now have 60 days to provide training to families. All families, including those that have said they are not interested have been invited for training sessions in March.
- CalFresh- Beginning June 2019, all SSI recipients will qualify for Cal Fresh.
 DDS has entered into an agreement Regional Centers to assist with outreach
 and the application process. Each regional center will be provided monies to
 accomplish this outreach and assistance.
- Board Training The committee members present at the last Board training session shared that the session on "How to Become a Stronger Advocate" was very informative and inspiring.
- CAL ABLE Training- Staff will coordinate with a representative from the State Council to provide a training for families. This presentation will be an overview of how the individuals served can keep their benefits through the ABLE Act.
