EXECUTIVE DIRECTOR REPORT

Anthony Hill, Executive Director, shared the following information:

- Richard D. Davis Foundation Golf Tournament the event took place on October 7th. The foundation appreciates the support and participation of the vendor community.
- o *ARCA Update* Mr. Hill attended a meeting for "Next Generation Directors"
- *Vendor Partnership* Mr. Hill will have a closed-door meeting with the

- VAC to discuss the partnership between the vendor community and SG/PRC.
- O Self Determination DDS will do another drawing on November 22, 2019. This drawing will be more targeted and will focus on individuals over the age of 22, individuals who are siblings of people in the program, and individuals who have parents serving on the advisory committee. Also, DDS will overdraw in case those selected choose to drop out.
- o Family Home Agency Survey A Family Home Agency (FHA) approves family homes which offer the opportunity for up to two adult individuals with developmental disabilities per home to reside with a family and share in the interaction and responsibilities of being part of a family. DDS has a strong focus on this type of residential settings and have allocated money for two positions to create two more Family Home Agencies.
- CalFresh There is going to be a mailing of flyers to families that qualify for the program. Families will be provided with support to sign up.
- AB 5 Independent Contractors This bill will be under legislation. Regional Centers will be responsible for the correct and clear categorization of workers. Regional centers will have to use this "ABC Test" when using the services of Independent Contractors:
 - The worker is free from the control and direction of the hiring entity in connection with the performance of the work, both under the contract for the performance of the work and in fact.
 - The worker performs work that is outside the usual course of the hiring entity's business.
 - The worker is customarily engaged in an independently established trade, occupation, or business of the same nature as the work performed.

SG/PRC staff has consulted with the legal firm, Enright and Associates, for feedback and will stay close to legal guidance.

PUBLIC COMMENTS

Valerie Donelson expressed her gratitude towards Mr. Hill for his support to the vendor community.
