The Committee members were reminded that the DDS directive requires the funds, \$56,719, allocated to SG/PRC's SDP LAC support the Implementation of SDP be encumbered by June 30, 2020 and all

funds need to be used by March 2022. SG/PRC will work with the SDP LAC to develop and post a "Notice of Request for Proposal (RFP)"
