- 2) <u>Introductions of committee members and public</u>- Introductions were made by Committee members, as well as by audience.

The outcomes were to allocate 70% of funds to Support/Coaching for Transition to SDP; 20% of funds to Collaborative Groups/Workshops; and 10% to Additional Identified needs. Aaron Christian (SGPRC) agreed to add funding amounts to a Request for Qualifications (RFQ) and send a copy to the committee. RFQ to be posted by May 15, 2020.
- 7) <u>Vote on Vice Chair</u>- the Chair, Mr. Ali, motioned to vote on Ms. Monterey to be elected as the Vice Chair and Mr. Rodriguez

seconded it. Motion to vote to Ms. Monterrey as Vice Chair: Approved. See voting grid at the end of the minutes.

8) Second Public Comment Period- During the public comments, an audience member posed the question to SGPRC about the length of time to have a budget certified and spending plan approved. SGPRC discussed establishing formal turnaround times for those items and will provide feedback at the next meeting. Also, recommended to contact Director of Client Services to discuss specific issues related to spending plan approval for the audience member.

There was also a discussion amongst the committee members about the need to meet more frequently to review and discuss the progress on the SDP grant funds. The committee agreed to set another meeting date on May 26, 2020 at 6:00pm to address this topic as well as other agenda items.
