May Revise/Proposed Changes/Regional Center Services & Trailer Bill SB188

- The Family Cost Participation Program and The Annual Family Program Fee are suspended through June 2023.
- o The first provider rate increase will start 6 months early (January 2023). The second and final one will begin a year early (July 2024). The funds shall mostly go to DSPs.
- o Enhanced service coordination for 0-5-year-olds, zero/low POS (1:40 caseload
- o There may be a significant overhaul of the fair hearings process
