2023 ANNUAL SCHOLARSHIP

n partnership with the San Gabriel/Pomona Regional Center (SG/PRC), we seek to improve the quality of life of developmentally disabled individuals served by the regional center and their families. This Foundation provides assistance and support to activities which would otherwise not be available through the center or any other agency.

As a part of the Foundation's mission, we aim to support higher education goals for individuals that support the SG/PRC community through an annual scholarship award. We are now accepting applications for the **2023 Annual Scholarship** award from employees of the San Gabriel/Pomona Regional Center vendor community, and for immediate family members of an individual served by SG/PRC.

ELIGIBILITY CRITERIA

The applicant must be one or more of the following:

- Current employee of a SG/PRC vendored service provider. (See A)
- Current employee of a non-SG/PRC vendored service provider (Serving a majority of SG/PRC individuals in the vendored service. Verification will be required.). (See A)
- Immediate family member (parent, child, or sibling) of an individual served by SG/PRC. (See B)

A. For employees of a vendored or a non-SG/PRC vendored service provider, the applicant must also:

- Be enrolled in a degree program at an accredited school pursuing an Associate's Degree or Bachelor's Degree in a field of study related to the regional center population, i.e., human services, child development, special education, psychology, social science, health science. May also include some vocational programs, trade schools, professional certification.
- ✓ Have a minimum grade point average of 2.5 or be in good standing in program.
- ✓ Have plans to continue to serve individuals served by SG/PRC.

B. For immediate family members (parent, child or sibling) of individuals served by SG/PRC, the applicant must also:

- Be enrolled in a post-secondary educational institution such as an accredited university, community college, academy, or institute of technology. May also include vocational programs, trade schools, professional certification.
- ✓ Have a minimum grade point average of 2.5 or be in good standing in program.



APPLICATION PROCESS & INFORMATION

COMPLETED APPLICATION SHOULD BE SUBMITTED WITH THE FOLLOWING:

- A one-page letter describing how you plan to make a difference, and indicating why you believe you qualify for this scholarship.
- Two letters of recommendation from people who have observed the applicant in a capacity of service or support.
- A copy of latest transcript, and/or acceptance into degree program or field of study are also required.
