Application Process for Wait List

You will be completing the information required for your San Gabriel/Pomona Regional Center (SG/PRC)/Brilliant Corners Housing Opportunity Wait List application. You are only eligible to apply if you are currently served by SG/PRC, have a Unique Client Identifier (UCI) number, are 18-years of age or older, and receive SSI/SSA benefits or have another form of income. Completed applications for the SGPRC/Brilliant Corners Housing Opportunity Wait List will be considered for one (1) bedroom in a newly built Accessible Dwelling Unit (ADU). However, an application to the waitlist does **NOT** guarantee a room.

The application period to apply for the SG/PRC/ Brilliant Corners Housing Opportunity Wait List will begin June 17, 2024, and will close July 26, 2024 at 5:00 PM. You may **ONLY** apply **ONCE**.

Submit applications through ONE of the following: Fill out the General Application and e-mail to housinglottery@sgprc.org OR hand deliver the General Application to the SG/PRC located at 75 Rancho Camino Drive, Pomona, CA 91766. Please submit hand delivered applications directly to the receptionist on the 1st floor near our front door. You may drop your completed General Application off Monday-Friday from 8:00am-5:00pm. Blank General Application will be available in our reception area in English and Spanish. You may also request a paper version of the intake form from your service coordinator so that you may print it out, complete it, and drop it off at SGPRC. If you need assistance completing this application, get in contact with your SGPRC Service Coordinator.

The SG/PRC/Brilliant Corners Housing Opportunity Wait List will be randomized, and names drawn for the wait list according to a lottery system. All completed applications received by July 26, 2024, will be entered into the lottery. The lottery will be held live on zoom on July 31, 2024, at 6pm. The lottery results will determine your waitlist number, and position on the wait list. Applicants will be notified of their awarded wait list number by e-mail and/or letter that will be mailed on August 1,

2024. Applicants will be processed for available bedrooms in the order of their wait list number, starting with wait list number #1 on the SG/PRC/Brilliant Corners Housing Opportunity Wait List.

If selected the applicant and/or their legal representative will need to enter into a rental agreement with Brilliant Corners.
